**Monitoring of Review Petitions as on 31.08.2015**

As per weekly reports submitted by the Regional Offices and Review Committees at Headquarters for the week ending 28-08-2015, the present position of the Review Petitions in each region and Headquarters is explained as under:-

- Lahore** Five Review Petitions are pending. One Review Petition is pending for more than 45 days. **F/A**
- Karachi** Fifty four Review Petitions are stated to be pending. However, no petition has been shown pending for more than 45 days. Dates of filing of Review Petitions are given in seven cases which have been filed during the last week **but not in rest of the 47 cases. A letter has been sent to provide the dates of filing of these cases. F/B**
- Peshawar** Three Review Petitions are pending and all are for more than 45 days. **F/C**
- Quetta** Only one Review Petition has been shown pending since June, 2015 and it is stated that the same had been sent to RO, Karachi for hearing. **F/D**
- Multan** Two Review Petitions have been shown pending but none is pending for more than the statutory period. Dates of filing of total eight cases have been indicated. **F/E**
- Faisalabad** Six Review Petitions are pending. Three cases are pending for more than 45 days and these cases are under process with Mr. Jaweed Akhtar, Sr. Advisor at Head Office. **F/F**
- Sukkur** Ten cases are pending out of which two are pending for more than 45 days. Dates of filing of cases have been given. **F/G**
- Hyderabad** Only one case is pending. Date of filing has not been indicated. A letter has been sent to provide its date of filing. **F/H**
- D.I.Khan** Not a single case is pending. **F/J**
- (Mr. Taimur Azmat Osman, Sr. Advisor) Head Office Out of twenty nine pending cases, seventeen have been heard. No case is pending for more than 45 days. Dates of filing in all cases have been shown. **F/K**
- (Mr. S.M Tahir, Sr. Advisor) Head Office Twelve cases are pending. Hearing has been fixed for 7<sup>th</sup> & 8<sup>th</sup> of September, 2015 of all cases. No case is shown pending for more than 45 days. Dates of filing have not been shown. **F/L**
