The Terms of Reference (TORs) of the National Committee on Children are as follows:-

1. Monitor the status of rights of children in Pakistan, especially the children at risk; and redressing grievances of children through Advisor / Grievance Commissioner for Children, appointed by Hon'ble Wafaqi Mohtasib.
2. Address systemic issues relating to child rights through:
 - a. Broad-based consultative meetings with key stakeholders;
 - b. Formation of thematic Task Force or Sub-Committees;
 - c. Initiating/ sponsoring research studies relating to child rights;
 - d. Raising awareness about child rights and protection thereof through electronic and print media, seminars and other available means;
 - e. Other steps, as deemed appropriate by the Committee;

3. Recommend Policy and legal reforms for the protection and welfare of children; and
4. Perform such other functions as it deems necessary for the protection and promotion of child rights.
