**INTERNSHIP PROGRAMME**

The Wafaqi Mohtasib Secretariat (WMS), invites applications for hiring of thirteen (13) interns (05 at Head Office and 02 each at Regional Offices, Lahore, Karachi, Peshawar, and Quetta) for a period of 04 months from the date of joining, but extendible. However, the number of interns may be increased/decreased as per need.

2. **Internship Purpose:** Learn from senior leaders and develops skills while working in the following functions:-

- Investigation of cases of mal-administration against Federal Government Organizations/agencies.
- Investigation/ Appraisal/ Implementation Wing.
- Administration/ Accounts Wing.
- Coordination Wing dealing with study of systematic issues and new initiatives.

3. Eligibility Criteria and terms and conditions of the Internship Programme are as under:-

- a. Fresh Graduates/ Post Graduates who have completed their degree in the year 2023-2024;
- b. **Education:** 16 years of education. Latest/ final degree should be from any educational institution recognized by the Higher Education Commission;
- c. **Field:** Graduates in Law or Public Administration;
- d. **Age Group:** The age group will be 23 to 28 years on the closing date of advertisement;
- e. **Nationality:** Pakistani National;
- f. **Minimum Percentage:** At least 70 % marks or 2.9 CGPA;
- g. **Gender:** Both male and female are eligible;
- h. **Employability Status:** Should not be employed in any Government or private organization;
- i. **Student Status:** Must not be a student of any public or private educational institution;
- j. **Remuneration/Stipend:** These interns will be paid Rs.40,000/- per month as remuneration during the period of internship;
- k. **Award of certificate:** A certificate of completion of internship shall be awarded to all those interns who will have at least 95 % attendance during the internship and satisfactory performance.
- l. No TA/DA shall be admissible for appearing in interview.
- m. Due to large number of applications it is not feasible to respond to every application. Only the short listed/selected candidate will be called for interview.
