4. "Technical Bids" will be opened in the office of Wafaqi Mohtasib Secretariat Karachi on **17/04/2021 at 12:00 noon** in the presence of the bidders or their authorized representatives. Whereas, the Financial Bids of technically qualified (i.e. compliance to technical specifications and other terms & conditions) bids shall be opened publically, later on.
